# Your rights

• Under the General Data Protection Regulation (GDPR) and The Data Protection Act 2018 (DPA) you have rights regarding your personal <u>data</u>.

# Data Security

All data usage with enims is controlled by our data protection officer who oversees how data is stored, who has access to that information and that all data is stored securely.

Your personal data will be treated as strictly confidential and will be shared only within enims and relevant clients for business purposes. We will only share your data with third parties outside of the company with your consent.

## How we collect data:

Most data obtained will be directly requested from us but we may also obtain data from internal sources or from other colleagues within your organisation.

## Internal data

We may ask for personal data during the recruitment process and will only hold this data for recruitment purposes, this data will be kept on record for up to 2 years following any recruitment activities. Employee data relating to the categories listed above and relevant skills and competency information will be kept for the duration of the employment contract and retained for as long as deemed necessary.

## **Google Analytics**

party service, Google Analytics, to collect standard internet log information and details of visitor behaviour patterns. We do this to inform us as a company about the number of visitors to the various parts of the site and the information our visitors look at on our website. This information is only processed in a way which does not identify any individual. We do not make, and do not allow Google to make, any attempt to find out the identities of those visiting our website.
